






53% of clients disclosed more than one type of victimization. 30% of clients received services from more than one SAFE program in FY20.

SAFE outcomes	Why this matters
99% of adult counseling clients report an increased ability to manage the effects of trauma.	"By managing the effects of trauma, adults are more likely to have a reduced sense of shame and guilt, to be more productive in their everyday life, and can have healthier relationships." 92% of youth in residential programs identified one positive relationship with a trusting adult.	"Children who come into our care have not had the experience of a trusting adult. Having a caregiver whom they can rely on for stability allows for genuine connection and an opportunity for them to heal and grow in new ways." Allison Mehta, Youth Care Worker
100% of sexual assault survivors report a sense of regained control.	"Following a sexual assault, survivors face complex decisions that affect multiple domains of their lives for years. 91% of Deaf community members report that they have increased confidence to respond to harmful behaviors in a survivor-centric way.	"In order to have a thriving and healthy Deaf community, survivors need to feel supported and for community members to have tools to prevent, reduce, and eliminate violence."
