

The SAFE Alliance Luxury Raffle

OFFICIAL RULES

1. TO ENTER. From May 1, 2021 from 8 p.m. through 8 p.m. on Saturday, November 6, 2021, ("Entry Period"), entrants may enter The SAFE Alliance Luxury Raffle ("Raffle") by purchasing a raffle ticket through and completing a registration form which will include name, complete address, city, state, zip code, e-mail address (if available), and telephone number.. Online ticket sales will be available until 8 p.m. on Saturday, November 6, 2021.

OFFICIAL DRAWING. The official drawing for the winners will take place at 9 p.m. on Saturday, November 6, 2021.

2. SPONSOR. The Raffle is sponsored by The SAFE Alliance, a Texas non-profit corporation (the "Sponsor"). All decisions of the Sponsor are final.

3. CONDITIONS. An eligible entrant may only enter via the ticket purchasing methods as described above. Incomplete entries are void. By entering, entrants acknowledge compliance with these official rules including all eligibility requirements. All entries become the property of the Sponsor and will not be returned. Neither Sponsor nor advertising and promotion agencies are responsible for incorrect or inaccurate transcription of entry information, or any other error or malfunction, or late, lost, illegible or misdirected entries. Entry materials that have been tampered with or altered are void. No copies, facsimiles or reproductions of entries will be accepted. Purchased raffle tickets are non tax-deductible.

4. DETERMINATION OF WINNER. A random drawing will be conducted on Saturday, November 6, 2021 from among all eligible entries received. Odds of winning depend upon the number of eligible entries received, not to exceed 2,000. The winner will be notified by telephone, mail, and/or email. The winner will be required to complete an affidavit of eligibility and release, which must be completed and returned within fourteen (14) days of issuance of notification or an alternate winner will be selected. Any attempt to deliberately damage the content or operation of this Raffle is unlawful and subject to legal action by the Sponsor or its agents.

5. PRIZES. The three prizes are 1) a three year lease of your choice of a Mercedes-Benz C 300 Cabriolet MSRP \$60,020 or a Mercedes-Benz E 300 Sedan MSRP \$60,725, or a \$20,000 credit toward your choice of a new Mercedes-Benz of equal or greater value; (Due to world-wide inventory shortage, the vehicle may need to be ordered and will not be available when the raffle takes place) 2) a piece of diamond jewelry valued at \$5,000 or 3) a \$1,000 gift card to Nordstrom. No substitution or transfer of prizes is permitted, except Sponsor reserves the right to substitute a prize of comparable or greater value, if a prize cannot be awarded for any reason. Vehicles pictured are for display purposes only.

6. ELIGIBILITY. The Raffle is open to those who are 18 years of age or older as of August 1, 2020. The Raffle is void where prohibited. The SAFE Alliance Employees and their immediate families are not eligible to win the grand prize. Immediate family is defined as, through blood or marriage, one degree of familial relationship (including in-laws and step-family), such as your spouse, your siblings, your parents, and your children. Immediate family does not include other family members (including in-laws and step-family), such as grandchildren, grandparents, nieces, or nephews. Void where prohibited or restricted by law.

7. TAXES. All applicable federal, state and local tax associated with winning the prize in the Raffle will be the sole responsibility of the winner. The winner shall be provided a 1099 form for income tax purposes because the value of the prize exceeds \$500. The winner will also be liable for the title and license fees and paperwork, if any.

The SAFE Alliance will file an IRS Form 1099 MISC with the Internal Revenue Service reporting the value of the prize as income to the winner. Prior to receipt of vehicle credit and no later than December 31, 2020, winner will provide The SAFE Alliance with a completed and signed IRS Form W-9 and Form W-2G and must remit cash payment for total taxable income to satisfy 25% of U.S. income tax withholding. Total taxable income to the winner is equal to the amount of \$20,000 credit, less cost of total cost of all raffle tickets purchased by the winner.

8. LIMITATIONS ON LIABILITY AND DISCLAIMERS. Sponsor, its employees and its Directors will not be responsible for or liable to any prize winner, winner's family or estate for any submissions of entries that are lost, late, illegible, damaged, incomplete, or incorrect. Sponsor can, at any time it chooses, without recourse, decide to terminate or modify the Raffle if the integrity of the Raffle appears to be compromised. If the raffle is cancelled, all monies paid for raffle tickets will be returned to entrants less processing fees. Decisions of the Sponsor related to the winner, interpretation of official rules, and other matters related to this Raffle are final.

10. GENERAL. Winner consents to the use of his or her name, biographical information, photographs and/or likeness for advertising and publicity purposes without additional

compensation, except where prohibited. Sponsor reserves the right to verify eligibility qualifications of the winner. Purchased tickets are not tax deductible, nor considered a donation to the Sponsor.
